

## PUBLIC NOTICE No. 04/2025 — Technical analysis of proposals

(item 5.4, IV, Public Notice No. 01/2025)

**Process:** Procedure for Expression of Interest — PMI No. 02/2025

**Purpose:** Selection of a specialized technical partner to support the structuring, development, monitoring, verification, and certification of jurisdictional carbon credits for the State of Pará.

The Companhia de Ativos Ambientais e Participações do Pará S.A., a mixed-capital company linked to the Government of the State of Pará, in the exercise of its legal and statutory rights, hereby announces the result of the Expression of Interest Procedure — PMI No. 02/2025, aligned with current law, the state's climate governance instruments, and the management of environmental assets within the territory of Pará.

During the process, the proposals submitted by the companies Systemica Inteligência em Sustentabilidade S.A. and BR Carbon Serviços Ambientais Ltda. were analyzed according to the technical, legal, methodological, and economic-financial criteria established in the PMI No. 02/2025 opening notice. The analyses strictly followed the parameters set forth in items 8, 9, and 10 of the PMI, with a detailed evaluation in three scoring sessions: Legal Structure (100 points), Economic-Financial Proposal (450 points), and Technical and Methodological Proposal (450 points), totaling 1,000 points.

After technical, legal-documentary, and economic-financial analysis, conducted in accordance with the principles of legality, transparency, efficiency, and equal treatment, it was concluded that the proposal presented by the company Systemica Inteligência em Sustentabilidade S.A. obtained the highest overall score, standing out for presenting: (i) a robust and innovative technical proposal for structuring the jurisdictional carbon credit system; (ii) a consistent MRV methodology with technology transfer and institutional capacity-building for CAAPP; (iii) a viable and sustainable economic-financial model; and (iv) a legal structure compatible with the object of the procedure.

In view of the above, the Executive Board of CAAPP publicly announces the result of PMI No. 02/2025, which is to grant SYSTEMICA INTELIGÊNCIA EM SUSTENTABILIDADE S.A. preference for negotiating the contract of a specialized technical partner to support the structuring, development, monitoring, verification, and certification of jurisdictional carbon credits for the State of Pará, according to the technical, legal, and economic-financial criteria established in the notice.



Pursuant to the provisions of item 5.4, subsection V, of the notice of PMI No. 02/2025, it is informed that the period for submitting a possible request for reconsideration will be from October 30 to November 5, 2025.
